



# How to Log On to the State of Alaska Online Public Notice System


**Step 1:** Go to url <http://www.state.ak.us>




**Step 2:** Click on "Public Notices legal, bids"

**Body of Notice:**

The Office of Children's Services (OCS) seeks letters of interest from eligible applicants for the Child and Family Visitation Center grant program. A Request for Letters of Interest (RFL01) is being issued for the following services:

Child and Family Visitation Center services. The Child and Family Visitation Center must provide a safe, secure, and confidential environment where a child and parent separated by a court order can meet, supervised by trained workers. The highest priorities are to provide child safety and enhance child and parent relationships. The Center will also communicate with OCS workers and foster parents, birth parents, and family members. The Center must provide information through court testimony when appropriate. OCS is also looking for a Center that can provide transportation to and from visits. The target population is those in the Anchorage Region.

Subject to the availability of funding, fiscal year 2005 is the first year of a continuing grant cycle extending through fiscal year 2007 for this program.
